# Goods

10000000	Live Plant and Animal Material and Accessories and Supplies	This segment includes live, wild and domesticated, seeds and plants and animals. This segment also includes materials and equipment used in the care, containment and feeding of live plants and animals.
11000000	Mineral and Textile and Inedible Plant and Animal Materials	This segment includes unprocessed materials such as stone, soil and ores, refined base or precious metals, inedible plant, forestry and animal materials as well as natural or synthetic fibers and cloth, leather and animal skins, scrap and waste materials.
12000000	Chemicals including Bio Chemicals and Gas Materials	This segment includes inorganic and organic chemicals and compounds in solid, liquid or gaseous form used in an industrial or manufacturing process
13000000	Resin and Rosin and Rubber and Foam and Film and Elastomeric Materials	This segment includes rubber and plastic material, including elastomers that are used in manufacturing and construction
14000000	Paper Materials and Products	This segment includes paper used for commercial printing, forms, envelopes, reprographics, and tablets as well as value-added papers which feature special surface treatments, color, chemicals, or fiber content that meet specific needs.
15000000	Fuels and Fuel Additives and Lubricants and Anti corrosive Materials	This segment includes natural occurring gases and processed materials used to produce heat or power performance enhancing additives, processed materials designed to reduce friction and wear when introduced as a film between solid surfaces. This segment also includes materials used to reduce or prevent corrosion of metallic surfaces, and petroleum- based and synthetic waxes and jellies

20000000	Mining and Well Drilling Machinery and Accessories	This segment includes the machines and accessories necessary to burrow beneath the earth's surface or related processes for obtaining a natural element.
21000000	Farming and Fishing and Forestry and Wildlife Machinery and Accessories	This segment includes machines and accessories necessary to cultivate and preserve soil, trees, plants as well as those necessary for breeding of animals.
22000000	Building and Construction Machinery and Accessories	This segment includes the machines and accessories used in support of the construction, repair and maintenance of structures and roads.
23000000	Industrial Manufacturing and Processing Machinery and Accessories	This segment includes the machines and accessories necessary to manufacture or process products or components. This segment also includes machinery and equipment for manufacturing and processing of food and beverages, textile, leathers and fabrics and, lapidary equipment
24000000	Material Handling and Conditioning and Storage Machinery and their Accessories and Supplies	This segment includes the machines, accessories, and supplies necessary for material conveyance, lifting, rotating, tilting and turning and the safekeeping of goods in a depository such as a warehouse
25000000	Commercial and Military and Private Vehicles and their Accessories and Components	This segment includes vehicles used in the conveyance of persons or materials, such as automotive vehicles, spacecraft, marine craft, powered aircraft, motorized cycles and rail bound vehicles, as well as recreational motorized and non-motorized craft. This segment also includes components, accessories and systems used in the repair, maintenance and support of these vehicles.
26000000	Power Generation and Distribution Machinery and Accessories	This segment includes machinery for converting any of various forms of energy into mechanical force or converting mechanical force into electricity. This segment also includes mechanisms used to transmit power from an engine to an actuator and systems and components used in the distribution of electrical and mechanical energy such as motors, generators, transformers and transmissions.
27000000	Tools and General Machinery	This segment includes hand held devices as well as small or multipurpose pneumatic, hydraulic, mechanical, electrical or electronically operated devices used in the manufacture, repair and maintenance of products.

30000000	Structures and Building and Construction and Manufacturing Components and Supplies	This segment includes components, materials and systems used in the construction, repair and maintenance of structures and roads. This segment also includes structural shapes, prefabricated structures, interior and exterior finishing products, electrical and plumbing fixtures as well as lumber, building components and concrete.
31000000	Manufacturing Components and Supplies	This segment includes components and supplies commonly used or consumed in manufacturing and construction processes. This segment also includes industrial goods such as castings, forgings and extrusions, fasteners, bearings, bushings, industrial wheels, sprockets, gears, gaskets, seals and springs. This segment also includes abrasives, industrial adhesives, sealants and solvents as well as paints, primers, finishes and dyes.
32000000	Electronic Components and Supplies	This segment includes electronic components used (or consumed) in the manufacturing and maintenance of electronic or electro-mechanical devices and systems. Examples of commodities found within this segment include semiconductors, integrated circuits, circuit card assemblies and light emitting diodes.
39000000	Electrical Systems and Lighting and Components and Accessories and Supplies	This segment includes lighting fixtures and electrical components and supplies.

40000000	Distribution and Conditioning Systems and Equipment and Components	This segment includes systems, devices and components used to control the movement or conditioning of air, gases or fluids. This segment also includes equipment and components used in plumbing, air cooling or heating (HVAC).
41000000	Laboratory and Measuring and Observing and Testing Equipment	This segment includes the machines, equipment and tools used in laboratories, as well as measuring, observing and testing equipment
42000000	Medical Equipment and Accessories and Supplies	This segment includes the tools and machines, accessories and consumable supplies used by physicians or those in the practice of medicine or related fields. This segment also includes assistive and corrective devices for people with disabilities. This segment also includes medical equipment and supplies for animals.
43000000	Information Technology Broadcasting and Telecommunications	This segment includes communications and computer equipment as well as peripheral input, output and storage devices. This segment also includes networking equipment and general computer components and supplies such as printers, electronic storage media and connection cables.
44000000	Office Equipment and Accessories and Supplies	This segment includes office machines, equipment, accessories and supplies commonly used in the clerical and administrative function of a business. Examples include calculating, copying and mail handling equipment as well as drafting and stationary supplies and accessories such as writing instruments and desk organizers.
45000000	Printing and Photographic and Audio and Visual Equipment and Supplies	This segment includes photographic film, plates & paper, cameras, lenses & accessories, microfilm equipment, photographic studio equipment, photographic chemicals and supplies as well as printing industry equipment and supplies such as inks and washes.
46000000	Defense and Law Enforcement and Security and Safety Equipment and Supplies	This segment includes equipment and supplies used in defense, law enforcement and security. This segment also includes equipment and supplies for personal safety.
47000000	Cleaning Equipment and Supplies	This segment includes the equipment and supplies used in environmental protection and wastewater management as well as in the cleaning of offices and lavatories. This segment also includes commercial laundry and dry cleaning equipment.
48000000	Service Industry Machinery and Equipment and Supplies	This segment includes machinery and equipment used in a wide range of retail business service environments such as food service, banking, games and entertainment and other consumer goods and services
49000000	Sports and Recreational Equipment and Supplies and Accessories	This Segment includes equipment, supplies and accessories used in recreational activities such as sports, camping, hobbies, recreational fishing and hunting. Playground, fitness and spa equipment are also found here, as are collectibles (such as antiques) and awards.

50000000	Food Beverage and Tobacco Products	This segment includes human food and beverages as well as condiments, colorings, flavorings and preservatives used in the preparation of food or beverages. This segment also includes plant extracts, mineral supplements and vitamins for human consumption.
51000000	Drugs and Pharmaceutical Products	This segment includes natural or synthetic materials and compounds used in the prevention or treatment of disease in humans.
52000000	Domestic Appliances and Supplies and Consumer Electronic Products	This segment includes floor coverings, bedclothes, table and kitchen linen, towels, window treatments, domestic appliances, consumer electronics and kitchenware.
53000000	Apparel and Luggage and Personal Care Products	This segment includes non-industrial clothing, garments shoes or boots and accessories as well as briefcases, suitcases, trunks and travel accessories. This segment also includes articles or preparations used in personal hygiene and personal care
54000000	Timepieces and Jewelry and Gemstone Products	This segment includes portable and stand-alone timepieces, cosmetic and fine jewelry (often set with gems) worn for personal adornment as well as and precious, semiprecious, or synthetic stones.
55000000	Published Products	This segment includes published copyright material such as software, music, books, magazines, and newspapers, in print or electronic form.
56000000	Furniture and Furnishings	This Segment includes furniture used in domestic as well as office or business settings. Additionally, furniture of the sort often found in schools or libraries is included here. Last, institutional furniture is included here as well

60000000	Musical Instruments and Games and Toys and Arts and Crafts and Educational Equipment and Materials and Accessories and Supplies	This Segment includes teaching aids used in both school and home settings; educational items such as decorative supplies seen in school settings; and arts and crafts equipment and supply items. Musical instruments and accessories are also in this Segment, as are puzzles, toys and games.
64000000	Financial Instruments, Products, Contracts and Agreements	This segment includes financial instruments and products arising from contractual agreements of a financial nature.

70000000	Farming and Fishing and Forestry and Wildlife Contracting Services	This segment includes services associated with the production, management and protection of plants, soil and land resources as well as those related to the breeding of animals and services related to wildlife.
71000000	Mining and oil and gas services	Services provided to the mining and oil and gas industries.
72000000	Building and Facility Construction and Maintenance Services	This segment includes services associated with the construction and maintenance of facilities, buildings, structures, roads and infrastructure. This segment also includes trades such as general contractors, electricians, plumbers, carpenters, painters, and roofing, landscaping, gardening and pest control.
73000000	Industrial Production and Manufacturing Services	This segment includes contracted services associated with industrial and manufacturing processes.
76000000	Industrial Cleaning Services	This segment includes services associated with wastewater management. This segment also includes industrial cleaning services such as building site cleanup or janitorial services.
77000000	Environmental Services	This segment includes services associated with environmental protection and management as well as environmental science and technology. This segment also includes pollution control.
78000000	Transportation and Storage and Mail Services	This segment includes services associated with cargo and personal transportation.

80000000	Management and Business Professionals and Administrative Services	This segment includes services associated with the management and administrative functions of an organization or business. This segment also includes business administration, human resources, marketing, management consulting, legal, and real estate services
81000000	Engineering and Research and Technology Based Services	This segment includes services associated with professional engineering, information and computer technology, economic analysis, and manufacturing production planning and control as well as cartographic, weather forecasting, and other earth science services.
82000000	Editorial and Design and Graphic and Fine Art Services	This segment includes services associated with print and broadcast media such as editorial, advertising and public relations as well as graphic and fine art
83000000	Public Utilities and Public Sector Related Services	This segment includes services associated with the supply of power and water as well as the provision, management or enhancement of voice or data communications such as postal, telex, fax and telephone charges. This segment also includes the cable and satellite television, installation and service charges
84000000	Financial and Insurance Services	This segment includes services associated with finance, banking, investing and insurance. Included in this section are escrow services.
85000000	Healthcare Services	This segment includes services associated with both research and delivery of healthcare. This segment also includes traditional and alternative healthcare professionals such as doctors, nurses, and therapists as well as services related to alternative medicine. This segment also includes hospitals, clinics, lab services and pharmacists.
86000000	Education and Training Services	This segment includes services associated with the supply of information leading to a reasoned understanding of a science, art, or technique. This segment also includes the supply of formal instruction or supervised practice especially in a skill, trade or profession.

90000000	Travel and Food and Lodging and Entertainment Services	This segment includes services associated with tourism, travel or entertainment. This segment also includes services provided by restaurants, hotels, movie theaters, cinemas and sporting events as well as spas, fitness and health clubs
91000000	Personal and Domestic Services	This segment includes services associated with personal care and assistance such as domestic service and day and elderly care providers as well as hairdressers, manicurists, and pedicurists.
92000000	National Defense and Public Order and Security and Safety Services	This segment includes services associated with the maintenance of law and order as well as personal safety and property protection. This segment also includes military service and fire fighting services.
93000000	Politics and Civic Affairs Services	This segment includes services associated with the representation and advancement of culture, community or social interests through either public or private programs. This segment also includes refugee assistance and disaster relief.
94000000	Organizations and Clubs	This segment includes representation services provided by organization of persons that have a common interest normally charged for as membership or association fees. This segment also includes clubs, unions and trade associations as well as civic organizations.
